**Step One: Decision**

• A basic contract will be drawn up based on the parameters decided and signed by both parties. An invoice will be sent for the total amount of the agreed upon annual contract with (a) due date(s) as decided by both parties.

Step Three: Create

- All creative materials will be designed by HPR staff, and reviewed for compliance. Step Four: Partner
  - Once all other steps have been completed and the creative materials have been put in place, the partnership is complete! First right of refusal will be available at the time of contract renewal.
